Entry Requirements

- The Media Peace Awards are open to all media organisations in Australia. "Media organisation" refers to an organisation that conducts publishing and/or broadcasting activities in Australia.
- Material must have been printed or broadcasted in the Australian public media between 1 September 2006 and 1 September 2007.
- Material must be submitted by 5pm on Wednesday 19 September 2007.
- Material must comply with the Media Alliance Code of Ethics.
- It is the entrant's responsibility to obtain any and all permissions including the copyright owner's permission to have the material judged and possibly displayed at the presentation dinner.
- All audio and visual material must be on TAPE/CD/VHS/DVD with an accompanying typed summary of no more than half a page.
- All entries must be accompanied by a half page summary.
- If original piece is not in English, a translation needs to be provided.
- An entrant may submit multiple entries in one or more categories, but additional copies, nomination forms, and entry fees must be provided for *each entry*. For example, if your work is entered into two categories, two nomination forms and a \$220 entry fee is required.
- For television and radio submissions, one copy of your work must be provided *for each category entered*.
- For print submissions, three copies of your work must be provided *for each category entered*.
- For online submissions, three copies of your work, plus an active link to the relevant website, must be provided for *each category entered*.
- Each entry must be accompanied by a nomination form and a \$110 entry fee (including GST).
- The UNAA reserves the right to use all material submitted in the audio-visual presentation at the presentation ceremony and to reproduce it for the purpose of promoting the Awards.
- All entrants must certify that the entry is their original work and that it complies with all copyright requirements of the Awards.
- Please note entries/material submitted will not be returned.
